




Commonly Asked Questions




A driver can report safety-related vehicle and equipment defects, based on built-in North American Regulatory Inspection Schedules or for fleet or asset-specific categories defined on custom inspection checklists.

- Missing items like gas caps or cargo-securing hardware
- Malfunctioning brakes or other parts
- Cracked windshields, broken headlights, or other equipment damages







Fleet Complete Inspect is a more efficient, secure, and reliable way of complying with the U.S. Department of Transportation and Transport Canada DVIR mandates than stand-alone applications. It is embedded into Fleet Complete Hub for use by fleet administrators and mechanics, enabling them to receive defect alerts and efficiently schedule, complete, and track maintenance and repair activities.

FC Inspect can send alerts to minimize roadside risk when drivers are driving with a major defect or without having completed a DVIR. It also allows drivers to complete inspections for multiple assets (i.e. truck and trailer) at the same time and on the same DVIR.

04 How does Fleet Complete Inspect help with fleet maintenance and repair?

Defect reports provide detailed information for service repair scheduling and work orders to help minimize repair costs and downtime. Photos and documents like repair estimates can be stored with reports for added context and audit purposes. If a driver finds a defect that isn't fully repaired on their next inspection, they can send it back to the mechanic.
