

PTO usage tracking

Time and location-stamped reports

Power Take-Off (PTO) on commercial and industrial vehicles allows operators to transfer the power from a power source, usually a running engine, to an attached or a separate equipment, such as a lift or a jack-hammer. Fleet managers and business owners can benefit from monitoring the usage of PTO in the field for billing, maintenance and fuel tax credit purposes.

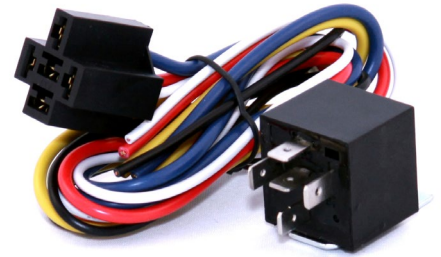
AT&T Fleet Complete vehicle and asset tracking solutions connect to the vehicle's power relay and capture the time the PTO was engaged and where it happened.

Different types of PTO equipment and activity tracked:

- Lifting and lowering the hook on the tow truck
- Rotation on/off status and duration on the cement mixer (compatible with ready-mix solution)
- Water pump engagement on a fire engine
- Operation of the boom on a bucket truck
- Engagement of the plow on a snow plow truck
- And more

Information captured on the Activity report:

- Type of activity: activities such as Ignition On/Off, Idle, Moving, Arrive/Depart location, engagement of input and driver behavior are captured on the report in chronological order
- From, To and Duration times: each activity has a start and end time with duration recorded in both minutes and seconds
- Start and End locations: asset's activity start and end are recorded with a street address, longitude and latitude
- During or after work hours: if an asset has been assigned a specific work schedule, each activity is tagged as during or after work hours
- Assigned resource: drivers and operators can be added into the system and assigned to the asset they are operating for greater accountability
