With add-on sensors, you can see when power take-off equipment is used, know when doors are opened, or track temperatures inside trailers or containers. And you can use accessories to increase the safety and security of your field staff, while also meeting regulatory requirements.

Working on site in the Oil & Gas industry, there are some special considerations with GPS Tracking. Your team needs the ability to turn off any cellular device, including their GPS Tracking devices, once on a job site to reduce potential interference with equipment. But you don't want to lose all your tracking data in the process.

Then, there are the remote working locations common in the industry, and people in the field working alone. For the industry, worker safety and security is equally important as meeting regulations.

### Radio Frequency switch

Our RF Switch allows the driver to turn off the GPS tracking device in their vehicle as soon as they arrive at the well-site to avoid cellular disruptions. Once the switch is activated, the vehicle's tracking device will stop transmitting location updates. Instead, it will store all the data until the switch is turned off.



### Driver ID

Driver ID enables you to quickly identify which driver is or was operating a vehicle at any given time. The starter disable option also offers an easy way to secure your vehicles against unauthorized use. You can increase accountability, efficiency and vehicle security at the same time.

### In-vehicle emergency button

Emergency button is installed in an easily accessible spot in the dashboard, enabling your workers to quickly notify dispatch in case of an accident or emergency.

### TPass Man Down kit

AT&T Fleet Complete integrates with the TPass Man Down Kit to deliver increased safety for workers who may be away from vehicle while on a job. When activated, the TPass will transmit an emergency alarm to the dispatcher via Fleet Complete, enabling assistance to be sent quickly.
